



## PREVENTION SPECIFIC EDUCATION/TRAINING GRID OCPSA

### OCPSA Grid Instructions:

In each Domain/Content Area, list in chronological order the 45 hours of university/college coursework or Continuing Education/ Training you have obtained. Each domain has a minimum number of hours required.

Once the minimum number of required hours have been met in each Domain Content Area the remaining hours can cover any Domain/Content Area. Nine (9) hours must be AOD Primary Prevention specific content. The **Prevention Content Area Definitions** can be found on our website under Licensure Requirements or Applications and Forms.

**Fifty percent (50%) of the 45 hours must have been completed within the two (2) year period immediately prior to filing the formal application.**

All education hours must be verified and included with the application. Acceptable forms of verification include: college or university official transcripts, copies of a continuing education certificate that verifies the course has approved CEU's.

If you have taken more classes than the number of rows provided, please fill out a second education grid. The hours listed on the grid represent the minimum number of hours required in each Domain/Content Area.
