Opening – Meeting began at 1:00pm

Announcements:

Trisha reported that Krysta Bennett has taken another position and will no longer be able to serve on the Prevention Committee. Tamie Sullivan is waiting to hear regarding board appointment at this time.

Jim Ryan provided information regarding ADAPAO's annual conference on May 2nd at Confluence Park in Columbus. Information will be shared at the conference regarding the new prevention scope of practice.

Derek Longmeier shared information regarding the Problem Gambling Network and the recent conference on Mitigating Harm, Maximizing Effectiveness to help participants learn about best practices and integration of problem gambling services into behavioral healthcare as well as community readiness.

Director Updates:

Alisia Clark announced that she will be leaving the Ohio Chemical Dependency Professionals Board effective March 22, 2019 and expressed her gratitude in working with the Board and all of the Prevention Committee members as well.

She also shared that the inner systems at the board are running efficiently and applications are being processed in a timely manner.

Scope of Practice Update:

The committee discussed follow up regarding the completion of the Scope of Practice. There are a few organizations who have supervisors that are not OCPC's and for various reasons cannot get the credential to supervise their program staff.

The committee agreed it will be important for these programs to contract for supervision to be in compliance. This information will be shared at the next Board Meeting.

Welcome Packet:

Derek discussed the plans for the welcome information for newly credentialed people and it was agreed the committee can start with some basic information and expand as progress is made. This may include information on the Website.

Work Plan Review:

The committee reviewed and updated the Work Plan grid. Alisia will update the Work Plan target dates and measures for the next meeting. The first priorities include developing talking points and presentation materials for the scope of practice prior to the ADAPAO Conference. The committee will also be looking into ways to share information throughout the state. Another priority is to identify priority groups and opportunities to market the importance of the credential for workforce development.
