Director Updates - Jill S.

- The legislature is not going to move to eliminate the Gambling Endorsement
- HB 452 – Representative Gayle Manning Sponsored on Bill – Introduced in Fall. Sponsor hearing has been held in the State and Local Government Committee but awaiting a hearing. Difficulty in awarding LICDC licenses esp. those with adv/accelerated degrees due to ORC requirements.
- Conferences: Addiction Studies Institute (ASI), July 21 & 22 (virtual)
- Ohio NADDAC Conference – in-person (April 28th, 29th), Westlake, OH (Cleveland area)
- PHP and CDP safe haven program. Working on Rules to roll out this alternative to discipline and support for those working in the field and needing additional recovery assistance, while providing safety to the public.
